MOTION FOR ENTRY OF AN ORDER OF NONSUIT


Plaintiff Home Paramount Pest Control Companies, Inc., through undersigned counsel, brings this Motion for Entry of an Order of Nonsuit, and in support states as follows:

1. Plaintiff brought this case against Justin Shaffer and Connor's Termite and Pest Control Services, Inc., alleging breach of contract (against Shaffer), Tortious Interference with Contract (against Connor's), Statutory Conspiracy to Injure Home Paramount (Va. Code §18.2-500)(against both defendants), Common law Conspiracy (against both), Violations of the Virginia Uniform Trade Secrets Act (Va. Code §59.1-336 et seq.)(against Shaffer) and a Request for a Temporary Injunction (against both defendants.)
2. On May 26, 2010, Judge White dismissed counts one and two of the complaint at a hearing on defendants' plea in bar; the order dismissing those claims was not a final order, because the remaining claims were and are scheduled for trial on June 29 and 30, 2010.
3. Plaintiff now moves this court for entry of an order of nonsuit pursuant to Va. Code § 8.01-380; such order would constitute the final order in this case.
4. None of the claims in this matter have been nonsuited previously.

5. No counterclaim has been filed in this case.

WHEREFORE, plaintiff Home Paramount requests that the Court enter the attached order of nonsuit.
